## 2819/24 Blennerhasset Playing Field

- (a) Play Area Cllr Telford reported there was no further progress with fund raising. Cllr Telford agreed to fix the No Dogs signage at the entrance to the Playing Field.
- (b) Play Area Inspection Members discussed the Play Area Inspection report received in January. There were no high risks identified. Members considered the recommendation that signage should be erected with information including the site address, contact information for maintenance issues and emergency contact details for the facility. The Clerk agreed to make enquiries regarding wording and cost of a suitable sign.

## 2820/24 Donation Request – St. Michael's Church, Torpenhow

Members considered the request for financial assistance towards the upkeep of the churchyard received from St. Michael's Church, Torpenhow. RESOLVED to support the request and grant £250.00.

## 2821/24 Noticeboard, Blennerhasset

Members discussed replacing the notice board at Blennerhasset. Initial enquiries to replace the noticeboard with an aluminium noticeboard would cost in the region of £900. The Clerk agreed to make further enquiries regarding the costs.

#### 2822/24 Use of personal email address/.gov domain name

The information from Active Councils regarding the move to a .gov domain was considered Members resolved that as it is not mandatory at the moment to have a .gov website the Parish Council would continue with the current arrangements.

#### 2823/24 Poor's Allotments, Blennerhasset

A mandate to update the correspondence address had been completed. Members noted that part of the area known as the Poors Allotments is registered to two addresses in Blennerhasset. As there is no governing document available for the Charity it was agreed to leave the matter in abeyance.

## 2824/24 Grass Cutting Tenders – Village Greens 2025-26 Seasons

Tenders had been invited for the cutting of the village greens and strimming the river bank. One tender had been received for the next 2 seasons grass cutting at a fixed price of £3129 per year and strimming the river banks three times a year at £95 per cut. The price being 5% more than the 2023/4 seasons. Members resolved to accept the tender.

#### 2825/24 Cumbria Constabulary Neighbourhood Policing Pledge

On 16th January 2025 Cumbria Constabulary launched its Neighbourhood Policing Pledge that committed the Constabulary to the provision of ten individual priority areas to further support communities and the Constabulary in the delivery of Neighbourhood Policing.

The second pledge relates to the provision of visible and accessible Neighbourhood Policing Teams that are committed to reducing crime and anti-social behaviour, and to improve public confidence. One aspect of this will be the requirement for local Neighbourhood Policing Teams to engage better with local council representatives. Specifically, the Pledge commits the Constabulary to twice yearly virtual meetings within each NPT locality with parish and town councils.
